The Tariffs and Services described below are governed by the “Port Rules” and Standard Terms and Conditions for Businesses at King Abdullah Port”.

(1)Pilotage	The charge for Pilotage is inclusive of Pilot deployment, Pilot launch, Pilot recovery to a maximum time of 2 hours thereafter detention charges shall apply		
(2)Towage	The charge for Towage includes the use of 2 tugs for a maximum of 2 hours per movement thereafter charges shall apply as per 6.3 below		
Vessel Acceptance	Vessels will be permitted to enter King Abdullah Port and the necessary service rendered only upon confirmation of completion of appropriate vessel registration and Government Agency approvals.		
Tug Deployment	The number of tugs required for the safe berthing and un-berthing will be at the sole discretion of the King Abdullah Port Vessel Traffic Services (VTS) Office.		
Service Availability	All Marine Services are subject to availability		
Disabled Vessels	Vessels without command, power, steering ability or any other defect that the Port Control Office considers to affect the safe maneuvering of the vessel will be charged at double the rate (5.1, 5.2)		
Excluded Vessels	No exclusions		
Tug Services	Tug services provided outside port limits are subject to separate negotiation.
